CONFIDENTIAL DISCLOSURE AGREEMENT

7. <u>Standard of Care</u>: Recipient shall protect the disclosed confidential information by using the same degree of care, but no less than a reasonable degree of care, to prevent the unauthorized use, dissemination; or publication of the confidential information as Recipient uses to protect its own confidential information of a like nature.

8. <u>Obligation</u>: Recipient's obligations shall only extend to confidential information that is described in paragraph 3.

9. Exclusions: This Agreement imposes no obligation upon Recipient with respect to information that: (a) was in Recipient's possession before receipt from Discloser; (b) is or becomes a matter of public knowledge through no fault of Recipient; (c) is rightfully received by Recipient from a third party without a duty of confidentiality; (d) is disclosed by Discloser to a third party without a duty of confidentiality on the third party; (e) is disclosed under operation of law; or (g) is disclosed by Recipient with Discloser's prior written approval.

10. <u>Warranty</u>: Each Discloser warrants that it has the right to make the disclosures under this Agreement. NO OTHER WARRANTIES ARE MADE BY EITHER PARTY UNDER THIS AGREEMENT. ANY INFORMATION EXCHANGED UNDER THIS AGREE-MENT IS PROVIDED "AS IS".

11. <u>Rights</u>: Neither party acquires any intellectual property rights under this Agreement except the limited rights necessary to carry out the purposes set forth in paragraph 4. This Agreement shall not restrict reassignment of Recipient's employees.
